- Payment must be made in full two weeks before your first market.
- There will be NO refunds for dissatisfaction of sales or booth location, change of mind, no-show or inclement weather.
- Vendors must abide by the market's rules and regulations as well as those of the Lodi Police and Fire Departments, State Board of Equalization and Health Department.

VENDOR RESPONSIBLE:

- Reading, understanding and following all Lodi Farmers Market Rules and Regulations. These rules and regulations are available online at www.lodichamber.com or at the Chamber office.
- · Assembling and staffing own booth
- Purchasing/supplying all materials and equipment necessary to properly and safely run the booth.
- Comply with all Police and Fire Department Rules and Regulations (Fire Department: 209-333-6735)
- Collection and handling of money for their business
- Booth display sign(s)
- Adhering to California State Board of Equalization regulations
- Cleaning your area after the event. Leaving no trash. Space MUST be left as found.
- No selling outside of your space is allowed.
- Complete and sign the mandatory Liability Clause below. Return original signed copy with Application. Keep a copy of all paperwork for your records.
- You will be given a 10' x 10' space for your booth.
- You may not sell any items not listed and approved by the Lodi District Chamber of Commerce

- San Joaquin County Temporary Food Vendor's Application (for any pre-packaged food)
