**RULES & REGULATIONS**

- The Lodi Chamber of Commerce expects the Artist/Group to perform in a "family friendly" manner and to always be in good taste for a diverse audience.
- In order to be in compliance with current copyright laws, the Chamber requires the Artist/Group perform music only in the repertory of ASCAP Clearance Express on their website at [ascap.com](http://ascap.com) and to verify that the music performed is ASCAP cleared.
- Sound equipment and lights necessary for the performance will be provided by the Artist.
- The volume of the sound must be conductive so other nearby vendors can conduct business. You may be asked to turn down the volume.
- Performance will begin on assigned date at 5:00pm through 8:00pm, unless otherwise approved/directed.
- Breaks: One 10 minute break for each hour of performance is allowed unless other arrangements have been made.
- If retained to perform, the agreement of the Artist/Group is subject to proven detention by sickness, accidents, riots, strikes, epidemics, acts of God or any other legitimate condition beyond their control. If the Artist /Group is unable to perform, the Artist/Group will take reasonable measures to provide a suitable alternate Artist/Group, who must adhere to all of the Chamber's Rules & Regulations.
- During the hours of engagements when the Artist/Group is not performing, the Artist/Group will be responsible to provide background music, i. e., streaming music through equipment. All music needs to be ASCAP approved.
- Artist/group may be called upon to make public announcements as requested by the Chamber.
